- Developing strong alliances with the community in the dispersal area in order to establish
  an information system that will identify land, which is under threat of development, likely
  sale, or poaching in the area.
- Develop programmes in order to sensitize landowners through landowners associations, self-help groups, women's groups, schools and other suitable groups.
- Making contact with like minded conservation groups, facilitate the establishment of a "Save the Migration Task Force" and to represent FoNNaP and The Wildlife Foundation on the Task Force.
- Since April 2000, I have coordinated the activities of FoNNaP in the Kitengela area and in 2000, successfully initiated an innovative Wildlife Conservation Lease Program. Started with two landowners in April 2000. To date there are 117 families involved and many more on the waiting list. Now there are 8,600 acres under the lease program.
