

MPA-MC Distribution Requirements 2009-2010

- 8 credits
- GPA of B average or better
- Full-time, in-residence
 - Min: 3 credits / semester
 - Max: 5 credits/ semester
- Satisfy the Distribution Requirements:

To graduate, all MPA students are required to complete at least one full credit with a grade of B- or better in each of the three areas listed below:

- Quantitative Methods
- Management and Leadership
- Democracy, Politics, and Institutions

To meet the distribution requirements, courses must be selected from the approved Distribution Requirement Lists (attached).

The full credit requirement may be satisfied through taking two half credit (i.e. module) courses.
